RESOLUTION OF WINSLOW TOWNSHIP FIRE DISTRICT # 1 PERMANENTLY APPOINTING LORRAINE AZZARANO TO THE PAID POSITION OF CLASSIFIED TITLE OF BUSINESS MANAGER

WHEREAS, by the adoption of Resolution No. #17-65 on June 7, 2017, the Winslow Township Fire District created the paid position of Classified Title of Business Manager pursuant to N.J.S.A. 40A:14-81.1; and

WHEREAS, by Resolution 17-90 on August 2, 2017 the Commissioners for the Fire District provisionally appointed Lorraine Azzarano to the position of Classified Title Business Manager; and

WHEREAS, the Commissioners for the Fire District have now determined to permanently appoint Lorraine Azzarano to the position of Classified Title of Business Manager pursuant to the further terms and conditions set forth hereinbelow.

NOW THEREFORE, BE IT RESOLVED by the Chairman and Commissioners of the Winslow Township Fire District #1, County of Camden, State of New Jersey as follows:

Lorraine Azzarano is hereby provisionally appointed to the paid position of Classified Title of Business Manager and shall perform all duties as directed by the Commissioners of the Fire District pursuant to N.J.S.A. 40A:14-81.1 and as further set forth on the position description attached hereto as Exhibit "A" and incorporated by reference herein.

Ms. Azzarano shall remain a Confidential Employee in this position.

BE IT FURTHER RESOLVED Lorraine Azzarano shall be entitled to all the benefits and privileges as set forth in the Collective Bargaining Agreement between the Fire District and I.A.F.F. Local No. 3249, AFL-CIO/CLE.


BE IT FURTHER RESOLVED this Resolution shall take effect immediately after a second reading and final adoption and publication as required pursuant to New Jersey Law.
